

PTI PHILOSOPHY OF MINISTRY

It is the burden and desire of PTI to establish the institute to the glory of God on biblical principles of training that elevate the role of the local church, eliminate the monetary burden upon pastors in training, and instruct on the essential doctrines for effective biblical shepherding. PTI is an independent Baptist entity that holds to the fundamentals of the faith as essential to the gospel and the Baptist Distinctives as Biblical, not preferential.

It is the strong belief of PTI that the local church should be more involved in training men for the ministry based upon II Timothy 2:2. We believe that this format is the most practical, efficient, and effective way to train men who otherwise could not go to Bible college or seminary.

It is not the desire to compete or replace the institutions of biblical education that are sound and successfully equipping men for full time ministry. PTI will fill a void that these institutes of biblical education cannot address. PTI will offer a certificate of pastoral training, through the traditional classroom setting, in a block course format, taught by well-educated pastors, with each student fulfilling an apprenticeship with the pastor of their home church. All this is provided at little to no cost to the student.

Each student will be required to agree to the doctrinal statement of PTI, give a clear testimony of salvation, have a commitment from their pastor to fulfill the apprenticeship program set up by PTI, travel to the location where each block course is being taught, and purchase the required books for each class. PTI will provide the room and board and tuition for each class taught.
